iFAST Corporation Ltd. Clinched "Best Investor Relations - Silver Award" at the Singapore Corporate Awards 2018

SINGAPORE (19 July 2018) — iFAST Corporation Ltd. ("iFAST Corp" or together with its subsidiaries, the "Group"), an Internet-based investment products distribution platform, and the parent company of FSMOne.com and iFAST Financial platforms, has won the "Best Investor Relations - Silver Award" in the "Companies with less than \$\$300 million in market capitalisation" category at the Singapore Corporate Awards (SCA). The SCA event was held on 18 July 2018 in Singapore. iFAST Corp had previously received the "Best Investor Relations - Merit Award" for First-Year Listed Companies at the Singapore Corporate Awards 2015.

According to the information published on the SCA website, the "Best Investor Relations" award recognises local listed companies that "embody the spirit of good corporate governance and corporate transparency; and hence adopt and implement best practices in investor relations (IR)". The winners are first screened and shortlisted based on various criteria, including the company's Singapore Governance and Transparency Index (SGTI) score, and other aspects such as responsiveness of the IR contact and the comprehensiveness/user-friendliness of the IR link, while the eventual winners are reviewed and evaluated by a panel of judges based on the information provided by the companies and evaluators. The Awards are presented in the following company categories: companies with market capitalisation of less than S\$100 million, companies with market capitalisation of S\$300 million to less than S\$1 billion, companies with market capitalisation of S\$1 billion and above, REITS & Business Trusts, as well as first-year listed companies. First launched in 2005, the SCA is co-organised by the Institute of Singapore Chartered Accountants (ISCA), Singapore Institute of Directors (SID) and The Business Times, and is supported by Accounting and Corporate Regulatory Authority (ACRA) and Singapore Exchange (SGX).

In more recent times, other than the recognition received at the SCA, iFAST Corp also emerged first runner-up in the "Best in Sector – IT " category of the "IR Magazine Awards

South East Asia 2017", an award celebrating the success of individuals and companies that are leading the way in IR across South East Asia. iFAST Corp was also ranked within the top 15% among SGX-listed companies in the SGTI released in 2016 and 2017.
