Mr Lim Chung Chun is a controlling shareholder of Accretion Investments Pte Ltd ("Accretion"). Accretion has certain shareholders, who are unrelated to Mr Lim or his associates, since before the listing of iFAST Corporation Ltd ("IFAST") on the SGX-ST in 2014. One of the shareholders has entered into a transaction with Accretion to swap her held shares in Accretion for the shares of iFAST held by Accretion. Following the transaction, Accretion's interest in iFAST was reduced. This led to the corresponding reduction of Mr Lim's deemed interest in iFAST.
