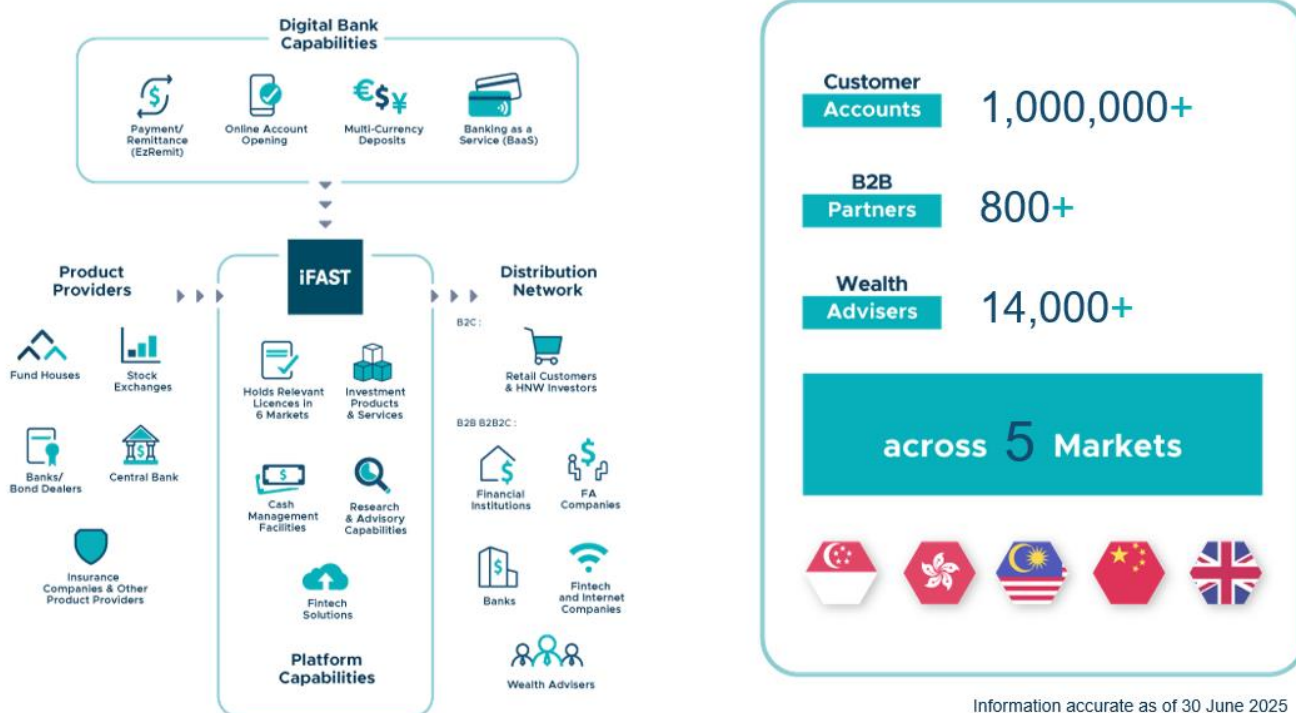

iFAST Bond API Solution addresses longstanding inefficiencies in the traditionally manual bond trading process. With this solution, trades are executed through a fully automated connection between a partner’s backend system and iFAST’s platform. Institutions gain direct access to over 1,500 global bonds within six to eight weeks of platform integration, reducing the need for in-house system development. iFAST Hong Kong is among the earliest platforms in Hong Kong to offer odd-lot bond trading via API. This function automates smaller-sized trades, making bond investments more accessible to investors. The launch of TreasuryNow API further expanded retail access to US government bonds in Hong Kong, reinforcing iFAST’s drive for innovation and financial inclusion.
